Supervisors oversee the work of others and can directly affect how work is performed. Under Ontario's *Occupational Health & Safety Act (the Act)* and regulations, employers must ensure their supervisors complete basic occupational health and safety awareness training as well as knowledge and competency-based training specific to the workplace. When supervisors fail to meet their health and safety obligations the consequences can be serious from worker injury and illness to Ministry of Labour orders and fines.

Under the *Criminal Code of Canada* supervisors, employers and managers can also be charged with criminal negligence and possibly jailed when they fail to protect the health and safety of workers and others in their workplace.

KNOWLEDGE AND COMPETENCY COMPLIANCE

Under the *Act* employers must appoint a *competent* person as supervisor. A competent person is one who:

- ✓ is qualified because of knowledge, training and experience to organize the work and its performance
- \checkmark is familiar with the Act and the regulations that apply to the work, and
- ✓ has knowledge of any potential or actual danger to health or safety in the workplace.

LEARNING OBJECTIVES

Through the program, participants will understand the key roles and responsibilities of supervisors and other workplace parties including:

- ✓ the Internal Responsibility System (IRS)
- ✓ the concept of due diligence
- ✓ the rights and functions of the joint health and safety committee (JHSC)
- ✓ the supervisor's role in work refusals
- ✓ Ministry of Labour workplace inspections
- ✓ JHSC or health and safety representative inspections and investigations
- ✓ *Criminal Code* provisions related to supervisors' duties and important case law.
