THE LAW

Certification Part I training is the first of a three-part process to attain and maintain Certification status for joint health and safety committee members in Ontario.

Joint health and safety committees (JHSCs) are required for every provincially regulated workplace with 20 or more employees or a designated substance on site. Employers must ensure at least two members of this committee, one representing workers and one representing the employer, receive **Part I** and **Part II Certification** training to become certified members. **Certification Part II** training must be completed within six months of **Part I** training. Save for a few exceptions, employers must also ensure certified members complete **Certification Refresher** training every three years. Regardless, all three parts of Certification training must be approved by the Ministry of Labour's Chief Prevention Officer.
