PREVENTION AND COMPLIANCE

Both experience and research evidence demonstrate the benefit of training when it is interactive, relevant and focused on identifying and controlling hazards. This training helps build workplace prevention capacity necessary to safeguard workers.

As such, health and safety law places significant health and safety training obligations upon employers. These include training to address the following issues.

JHSC Certification: Joint health and safety committee (JHSC) competency, especially for certified members, is critical for an effective workplace health and safety program. By law, employers must ensure certified members complete approved *Part I* and *Part II Certification* training, plus *Certification Refresher* training every three years.

Supervisor Competency: By Ontario regulation, supervisors must complete health and safety awareness training. Health and safety law also requires their competency. A competent supervisor is qualified because of knowledge, training and experience to organize the work, and its performance; and is familiar with the laws and regulations and any potential danger to health or safety in the workplace.

Working at Heights: Ontario employers must ensure workers on construction projects complete an approved working at heights (WAH) training program. Training is valid for three years, after which employers must ensure workers complete approved WAH Refresher training.



Other training requirements must address:

- ▶ Worker Awareness
- ▶ Transportation of Dangerous Goods
- ▶ Safe Lockout-Tagout
- ▶ Globally Harmonized WHMIS
- ▶ Workplace Violence and Harassment
- ▶ Mobile Equipment Operator Competency
- ▶ Confined Space Entry.
