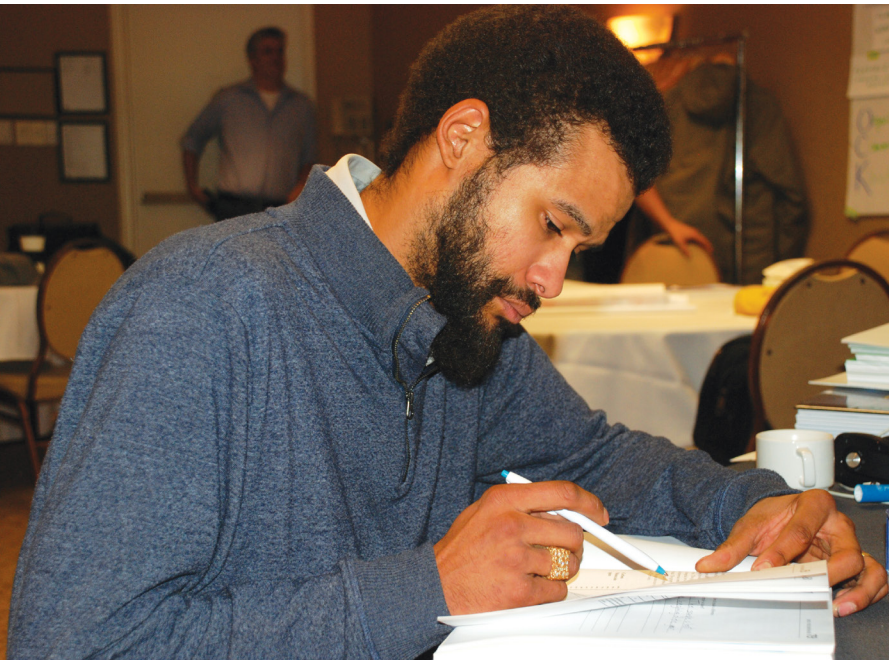

THE LAW

Before joint health and safety committee (JHSC) members can become fully certified, they are also required to complete a second round of training, or **Certification Part II** training.

This training must address at least six significant hazards that are identified by a proper workplace hazard assessment, conducted and discussed by the JHSC. Ideally though, training should cover all significant hazards in the workplace.

Regardless, **Certification Part II** training must also be approved by the Ministry of Labour (MOL), delivered by an approved provider and taken within six months of **Certification Part I** training.

WHSC CAN HELP

Like our **Certification Part I** training, all our training modules for **Certification Part II** have been approved by the MOL. Each is designed to build on the knowledge gained in **Certification Part I** training and apply to specific workplace hazards with an emphasis on potential health and safety effects, applicable health and safety legislation and effective control measures.



YOU HAVE OPTIONS

WHSC has developed more than 60 hazard-specific modules to meet this mandated training. These give workplaces the greatest flexibility and degree of customization. To help ease the process however, WHSC offers a second option, namely **Certification Part II** sector programs.
